Who you are

You are dynamic and passionate about developing and delivering accessible mental health services and changing lives. You are excellent at building relationships and partnerships with a range of individuals, groups and service providers in order to break down barriers that prevent people accessing services. You are motivated, organised and experienced in working in community settings.

What you will do

- Increase referrals into our services by engaging in a variety of ways with local communities.
- Organise, attend and speak at external events, groups and services (statutory health services, community groups, local health forums and other meetings) to promote our services and build new relationships and partnerships. This may include occasional weekend and evening work.
- Work closely with our communication & marketing team to help raise the profile of The Cellar Trust and increase access to our services. This will include support for communication strategies and input into the development of communication materials and social media content.
- Help to organise and run training sessions with internal and external colleagues and services.
- Update our partnership database with all necessary information.
- Attend all relevant team meetings, providing engagement and referral figure updates.
- Contribute to all necessary reporting and monitoring activity and gather formal and informal feedback to help shape and improve the work.
- Support co-production activities with local residents, service users and stakeholders to support ongoing development of the service, including running service user focus groups.
- Undertake a range mandatory and role specific training including safeguarding, data protection, health and safety and mental health awareness training.
- Work in accordance with all Cellar Trust policies and procedures.
- Perform any other duties relevant to the post, taking a flexible, team-based approach to the role.
